

Waiver and Release Form for the Jiu-Jitsu Summer Camp

Liability Release and Parental Consent Form

It is further understood and agreed that this waiver, release, and assumption of risk is to be binding on my heirs and assignees.

Consent for Treatment

This waiver and release form shall be governed by and construed in accordance with the laws of the United Arab Emirates as enforced in the Emirate of Abu Dhabi. Any dispute arising in relation thereto shall be subject to the exclusive jurisdiction of the courts of Abu Dhabi.
